INT. DMV OFFICE

Wide shot, show a line of people trying to get to the desk. Drab, florescent colours.

INT. DMV OFFICE

DMV DESK CLERK (Jon) and GIRL CLERK (Brandy) look down as the current patrons walk off.

DMV DESK CLERK  
Number 31, 32, and 33.

The next three patrons walk up to the counter, HARLEY, HOLLY, and GEORGE.

The lights go dim, and an unseen announcer's voice starts along with music.

ANOUNCER  
Ladies and Gentlemen, the Department of  
Motor Vehicles welcomes you to DRIVER'S  
LISCENCE EXAM!

The DMV desk clerk turns around and hold a microphone

DMV DESK CLERK  
Thank you! Let's meet out contestants.  
Oh my, who is this young hottie.

Host kisses Holly on the cheek ala Family Feud.

HOLLY  
My name is Holly, I'm a student at OSU  
and I love bike riding and pets.

DMV DESK CLERK  
Excellent. And you sir?

Host shakes hands with Harley.

HARLEY  
My name is Harley, I work at First Bank  
as an accounts manager.

DMV Clerk makes a THUMBS UP sign into the camera.

DMV DESK CLERK  
(to George)  
And you sir?  
(before George can answer)

DMV DESK CLERK
